- 2. The party/organization seeking permission for shooting would obtain NOC or any other licenses/ permissions required for the purpose like Delhi Police/Traffic Police from time to time.
- 3. Necessary clearance be obtained from Archaeological survey of India (ASI) if shooting involves protected monuments, forts etc. which comes under ASI.
- 4. Party is responsible for smooth flow of traffic.
- 5. The organizers shall abide by the regulations prescribed for the activity undertaken & also be liable for any tax/fine/penalty etc.
- 6. Party must ensure cleanliness of the area being used & no rubbish should be left at the site after the program.
- 7. The party/organization hiring the space will be responsible for all losses/ damages to the property, if any.
- 8. The sound level of the orchestra & any other music will be under the limits as per the norms of Central Pollution Control Board.
