- The application of obtaining film shooting permission is inducted with online payment gateway system. The applicant need to apply for film shooting permission on North DMC official website https://filmshooting.northmcd.com/
- Security amount of Rs. 25000 per permission (Only for North DMC properties) in form of DD is to be deposited at Directorate of Press & Information A-Block, 5th Floor, Dr. SPM, Civic Center, JLN Marg (Security Amount is refundable)

Sub: Policy for permission to Film shooting under the jurisdiction of North Delhi Municipal Corporation under National Policy on Ease of Doing Business (EODB).

List of Documents:

Following documents are required along with the online application form:-

- i. Photo ID of the applicant (Aadhar/Driving Licence, Voter ID, Passport, etc.)
- ii. Address proof of the applicant/organization.
- iii. An undertaking in the requisite format as per Annexure-B.
- iv. Any other document as decided by the competent authority.

Every application shall be accompanied with such fee to meet administrative expenses for examination of the application and the proposed work as the appropriate authority may, by general order, deem fit:

No person without the permission of the North Delhi Municipal Corporation shall shoot the film within the jurisdiction of North DMC. The Director (P&I) shall grant online permission for shooting on behalf of the Commissioner.

Terms and conditions:

The following shall be terms and conditions of the policy:

- 1. The applicant shall apply to the North DMC in the requisite format for permission to shoot in any building/area/location falling under the jurisdiction of the North DMC. It covers all buildings and open areas including the protected monuments of ASI, Heritage Buildings of North DMC, private properties like Farm Houses, Malls, Hospitals, Theaters, etc.
- 2. The applicant will also take NOC from concerned agencies i.e Traffic Police, Archeological Survey of India etc. wherever applicable, before starting shooting.
- 3. The applicant will be responsible for no nuisance and smooth flow of traffic.
- 4. The applicant shall abide by all the rules and regulations prescribed and also shall be liable for security, tax, fine and penalties etc.
- 5. The applicant will be responsible to ensure the cleanliness of the area being used and no rubbish/garbage will be left at the site after the shooting.
- 6. The sound level and orchestra and any other music will be within the limits notified by the Central Pollution Control Board (CPCB)/Delhi pollution Control Committee (DPCC).
- 7. The North DMC will not be responsible for any losses/damages to the properties of any party/organization.
- 8. The requirement of entrance and exit etc. will be the responsibility of the applicant/party/organization and they will be responsible for maintaining the proper law and order and traffic control etc.
- 9. If the applicant is unable to use the space without prior intimation, the fee shall not be refunded. In case the shooting cannot be undertaken due to any reasons and the applicant

- informs to take another date if available, the amount may be adjusted by the competent authority.
- 10. Any decision of the competent authority of the North DMC for interpretation of the terms & conditions mentioned herein above shall be final & binding on the party / organization.
- 11. The North DMC reserves the right to refuse/ cancel the booking of the space(s) of any party/Organization without assigning any reason.
- 12. There should be no controversial/objectionable/obscene material be put for display.
- 13. Eatables are not allowed in parks.
- 14. No doffing of the greens & construction of the Shamiyana in park will be permitted.
- 15. Liquor is strictly prohibited in all the states/venues.
- 16. No cooking is allowed.
- 17. If any of the above condition is violated then the Security amount will be forfeited.
- 18. The applicant will be responsible for any unforeseen circumstances in which he is unable to use the location/building.
